# THE PRE-AUTHORISATION PROCESS



PRE-AUTHORISATION IS AN IMPORTANT PART OF YOUR MEDICAL AID BENEFIT PROCESSES.

Pre-authorisation means to obtain approval from your medical aid for an in-hospital or in-rooms procedure prior to the surgery or admission date. The pre-authorisation ensures that the costs of the procedure may be covered by your medical aid benefits. Without the pre-authorisation, you can get a nasty surprise when the medical bill is not covered by the medical aid, and you are left to cover the expense out of your own pocket.

Sometimes, even if a procedure *is* covered by your medical aid benefits, you may not have enough benefits remaining to cover the full cost. So, with the pre-authorisation, you will be notified of what will be covered and the amount for which you would be liable. This way, you can be prepared for the costs and not be surprised by any unforeseen expenses. Most healthcare providers require a pre-authorisation from the medical aid, in order to proceed with the treatment.



### THE PRE-AUTHORISATION PROCESS (CONTINUED)

IF A HEALTHCARE PROVIDER HAS IDENTIFIED THAT YOU NEED A PARTICULAR PROCEDURE, YOU CAN IMMEDIATELY REQUEST PRE-AUTHORISATION. YOU CAN APPLY FOR PRE-AUTHORISATION IN THE FOLLOWING WAYS:


#### THE FOLLOWING IS IMPORTANT TO NOTE WHEN GETTING A PRE-AUTHORISATION:

- You will receive your pre-authorisation within 48 hours, which you then need to give to all the relevant providers, such as the hospital or day theatre, surgeon, and anaesthetist.
- If the procedure is not approved, you will not receive pre-authorisation, and you will be liable to pay for the procedure out-of-pocket. It is also important to note that pre-authorisation may not cover the full payment of the procedure, because healthcare providers often charge more than the set NAMAF tariff.
- We recommend that you get a quote for the procedure ahead of time, so that you can know how much the total cost is versus the amount that is made available by your medical aid, as indicated on the pre-authorisation. The difference will be your co-payment.
- It is important to understand that a preauthorisation is not a guarantee of payment. In
  the event that your benefits are depleted during
  the period of time between the issuing of your
  pre-authorisation and the date of procedure, or if
  your member status has changed (to resigned or
  suspended), you will be liable to cover the cost of
  the procedure. We may not be able to anticipate
  how your benefits are being used when approving a
  pre-authorisation. Pre-authorisations for pre-existing
  conditions or exclusions will be declined up-front.
- If you have obtained pre-authorisation, and you decide to cancel the procedure, kindly also notify the medical aid so that we can cancel the pre-authorisation event.
- Finally, in the case of an emergency hospital admission, your authorisation will be submitted to the hospital within 24 hours.

### WHY SHOULD I GET THE VACCINE?

When we get a vaccine, it activates an immune response in our body. This helps our bodies learn to fight off the virus without the danger of an actual infection, because the body will recognise the virus and be able to develop antibodies to fight it off. If we are exposed to the virus in the future, our immune system "remembers" how to fight it. All authorised COVID-19 vaccines provide significant protection against serious illness and hospitalisation due to COVID-19.

The **AstraZeneca vaccine** is made from a weakened version of the common cold virus, and has been scientifically modified to contain the Coronavirus, so that your body can recognise this virus and develop antibodies.

The **Sinopharm vaccine** is an inactivated Coronavirus vaccine, which means that it uses factors like heat or chemicals to kill the virus, and it also teaches the body to create antibodies.

#### None of these vaccines can give you COVID-19.

It takes time for your body to build immunity after vaccination, so you won't have full protection until 2 weeks after your final dose. It is important that you receive both doses of the vaccine for it to be as effective as possible.

Studies show that COVID-19 vaccines are effective at keeping you from getting COVID-19. Getting a COVID-19 vaccine will also help keep you from getting seriously ill even if you do get COVID-19. **Protecting yourself also protects the people around you**, like those at increased risk of severe illness from COVID-19 or those who can't get vaccinated — including infants, or people with weakened immune systems from things like chemotherapy for cancer.

Another benefit is that once you're fully vaccinated for COVID-19, you can safely resume many activities that you did prior to the pandemic.

### WHY IS THE VACCINE SAFE?

Millions of people globally have received COVID-19 vaccines, and these vaccines have undergone the most intensive safety monitoring in U.S. history.

Vaccines are authorised by the large health and safety bodies such as the U.S. Food and Drug Administration (FDA) and the World Health Organisation, which set strict standards for clinical trials and rigorously evaluates scientific data submitted by vaccine developers. Once vaccines are made available to the public, the FDA and WHO continue to monitor vaccines very closely for safety. The WHO also works globally with scientists to research and test the vaccines and their continuous safety/effectiveness.

Researchers began developing vaccines for COVID-19 more than a year ago in January 2020, based on decades of understanding immune response and how vaccines work. Thousands of volunteers participated in clinical trials that started that spring, making sure we can trust the vaccines to be safe and effective.

Based on the results, the FDA has authorised multiple vaccines for public use, and the World Health Organisation endorses these vaccines, including the AstraZeneca and Sinopharm vaccines that are available in Namibia. Doctors and medical experts with many years of experience regulating vaccines evaluated information about the safety, effectiveness, and manufacturing quality of the vaccines prior to making their decision.

After a vaccine is authorised by the FDA and the WHO and is made available to the public, experts continue to closely monitor the vaccines for ongoing safety and to help us learn more about questions like how long vaccines will provide protection.

## WHAT CAN I EXPECT TO EXPERIENCE AFTER GETTING THE VACCINE?

It's normal to experience some mild discomfort following a vaccine. This means it's working and creating an immune response in your body.

You may feel soreness or experience some swelling in your arm. You may also feel tired, have a headache, fever, or chills. These symptoms do not mean you have COVID-19 — it's NOT POSSIBLE to get COVID-19 from the vaccine.

These side effects may impact your daily activities, but they shouldn't last more than 2-3 days. If they continue or get worse, call your doctor, nurse, or clinic.

Even if you have these types of effects after your first shot, it's important to make sure you get the second one, unless a vaccination provider or your doctor tells you not to get a second shot or you get the vaccine that only requires one dose. Ask your doctor if you have guestions. Your

body takes time to build immunity. You may not be fully protected against COVID-19 until 1-2 weeks after your final shot.

It is very unlikely that you will develop severe side effects from the vaccine. In most cases, discomfort from fever or pain is normal. **However, contact your doctor or healthcare provider:** 

- If the redness or tenderness where you got the shot increases after 24 hours
- If your side effects are worrying you or do not seem to be going away after a few days
- If you develop severe headache, abdominal pain, leg pain, or shortness of breath within the first three weeks.
- If you get a COVID-19 vaccine and you think you might be having a severe allergic reaction after leaving the vaccination site, seek immediate medical care.



## WILL I GET LONG-TERM SIDE EFFECTS FROM THE VACCINE?

Serious side effects that would cause a long-term health problem are extremely unlikely following COVID-19 vaccination.

Long-term side effects following any vaccination are extremely rare. Vaccine monitoring has historically shown that if side effects are going to happen, they generally happen within six weeks of receiving a vaccine dose.

For this reason, it is required that each of the authorised COVID-19 vaccines be studied for at least eight weeks after the final dose. Millions of people have received COVID-19 vaccines, and NO long-term side effects have been detected.
